- \* Booth spaces are 10 ft. x 10 ft. If your set-up exceeds 10 ft. x 10 ft. you will be charged for an additional booth, i.e., trailer 9ft. plus 2ft tongue equals 11ft, so you need two booths.
- \* If you occupy an electrical booth, you will be required to pay the electrical booth price even if you do not use the electricity.
- \* **There are no water sources and no 220 electrical sources.** Electrical outlets are **ONLY** available in 110 voltages.
- \* Roads will be blocked off to through traffic at 10 p.m. on October 9<sup>th</sup>. We ask that you please unload your vehicle, park, and then set -up your booth to assist in the flow of traffic. Set-up must be completed by 8 a.m. on October 10<sup>th</sup>
- \* **All booths are required to remain set up and attended until 6 p.m. on Saturday, October 10<sup>th</sup> . No vehicles will be permitted to enter at the time of tear down. There will designated areas for loading your vehicle.**
- \* In order to reserve your desired booth, applications must be accompanied by booth rental fee *and a **separate** deposit check* in the amount of \$50. **All booth holders who remain until 6 p.m. will have their original deposit check returned to them.** Those who tear down early will forfeit the deposit. Checks and money orders should be made payable to the **Cabot Chamber of Commerce.**
- \* There will be no refunds and no rain date.
